- 1. Your declaration covers donations you have made in the four years prior to signing this form and any that you may make in the future. You must therefore notify Life For The World (LFTW) if you change your name or address while the declaration is still in force. You may cancel the declaration at any time by notifying LFTW - it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
2. I understand that LFTW will reclaim 25p of tax on every £1 that I give on or after 6 April 2008. I confirm that I have paid or will pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) that is at least equal to the total amount of tax that all charities or community amateur sports clubs that I donate to will reclaim on my gifts for that tax year. I also understand that other taxes such as VAT and Council Tax do not qualify for this purpose. (If your circumstances change and this is no longer the case, you should cancel your declaration - see note 1).
3. If you pay tax at the higher rate you can claim further tax relief for your Gift Aid donations on your Self-Assessment tax return.
